(10February,2015, Hong Kong) Shunfeng International Clean Energy Limited (“Shunfeng” or the “Group”; stock code: 1165) is pleased to announce Shunfeng Photovoltaic Investment (China) Co., Ltd, a wholly-owned subsidiary of the Group, has acquired 8 wind farm projects, with a total designed capacity of 723.5MW and an expected annual output of 1,615,213MWh for a total consideration of RMB442,710,000 (equivalent to approximately HK\$553,387,500).The acquisition projects are mainly located in Jilin and Hebei Provinces etc., which are districts and provinces with rich wind power resources. Most of the acquisition projects have obtained the national highest benchmark on-grid tariff which is RMB0.61 per kWh.

As for the acquisitions, the wind farm projects in operation are equipped with wind turbines of mature techniques and equipment of stable quality. The projects are also at a relatively stable operating cost with low-cost capital introduced, operation expense reduced to relatively low level.

Apart from the projects, the acquisitions also provide the Group with a team of wind power experts with more than 10 years of experience in wind power management, and professional expertise on wind power, including early development, project assessment, project construction and management as well as the operation and management of large power stations, which ensures that the projects continue their normal operation and implement future development plans.

Mr Zhang Yi, Chairman of the Group commented, “Our goal is to become a distinguished supplier, manufacturer and operator of clean energy by providing different kinds of clean energy power generation services, such as solar power generation and wind power generation. As one of the major energy sources in the PRC, wind power accounted for 3% of the national power generation and it is the third largest power source in the PRC. Pursuant to the “13th Five-Year Plan”, clean energy is one of the important strategic developments of the PRC, the PRC Government has implemented a series of supportive policies and important subsidy to enhance the efficiency of wind power. Through the acquisitions, we aim to expand our scope of business operations into wind power in order to widen our range of power generation and enrich source of income of the Group so as to become a fully integrated clean energy enterprise.”
